### CONFORM® Mattress Overlay System



The system is used as an overlay on top of the standard bed mattress. A complete mattress system consists of 4 sections which are held together by connectorstrips. With the four individual segments, there is the option of choosing a foam variant in the head and foot areas, which then do not need to be filled with air. The variants are listed below. The inflatable segments are equipped with two valves to enable inflation/deflation from either side of the bed. The use of a bed sheet on top of the mattress is mandatory. In case of the cremes on the patients skin, a waterproof cover must be used to avoid contact of creme with the natural rubber which could lead to material damage.
